Councillor Brazier said it was not on any capital plans – Councillor Ketteridge questioned if this meant the Parish Council was lied to and Councillor Brazier and others indicated it seemed Ivinghoe Parish Council was lied to. Councillor Ketteridge asked what the Parish Council can do, and it was agreed to write to Keith Carpenter and keep a paper trail of what is said.
